Allen: Maintenance needs to buy airless sprayer not to exceed \$500. Will use it for spraying bookcases for the new library and touching up unfinished projects in the park.

Allen: Dennis and Tim attended KPP (Kansas Power Pool) meeting. KPP wants to increase \$115-118k a year starting in 2022. In 2-3 years, rate may go back down. But 2022 rate will go up.
