

The Udall City Council met for the Special Council Meeting on Tuesday, February 3rd, 2021, at 6:30 p.m., at the Udall City Building. Stephen R. Brown, Mayor, called the meeting to order. Council members present were Janette Adams, Kenneth Ault, Brandon Lawrence, Matt McAllister, and Carlton Smail. Quorum established. Also present were Sara Barry, Erik King, Eric Allen, Tim Brooks, Aaron Hoy, Greg Harman, and Rose Mary Saunders. Library Wellness Center Change Order #3 Discussion: Aaron Hoy and Greg Harman of Harman Huffman Construction presented a Cost Proposal Increase from Harman Huffman due to the expiration of the original proposal and rapidly rising rates of construction materials. Rose Mary Saunders of Ranson Financial spoke of her similar experiences in her line of work. She suggested that since they've supplied documentation that they have locked in the new cost proposal with Alliance Steel Building Systems and provided sufficient bids that the City approve Change Order #3 in the amount of \$20,565.00. The Udall City Council met for the Regular Council Meeting on Monday, March 8, 2021, at 6:30 p.m., at the Udall City Building. Stephen R. Brown, Mayor, called the meeting to order. Council members present were Janette Adams, Kenneth Ault, Brandon Lawrence, Matt McAllister, and Carlton Smail. Quorum established. Also present were City Attorney Andrew Marino, Tony Russell and Justin Eastman of Old Skool Productions LLC, Erik King, Eric Allen, Emily Albers, Jerry Gardinier, Bertha Rhoads, Mitch Kratochvil and Sara Barry.

MODITIFACTION OF AGENDA: None BUSINESS FROM THE FLOOR: Emily Albers and husband Jerry Gardinier spoke of drainage issues at their rental property in town; City Attorney Andrew Marino addressed the couple and explained that there was an engineer in 2019 in town who informally took a look at the matter for the city. Earlier this month, KRHC launched the Kansas Emergency Rental Assistance (KERA) program, the largest initiative in our corporation's history. Funded by the federal Coronavirus Response and Relief Supplemental Appropriations Act of 2021, KERA provides rent, utility, and internet assistance to Kansas renters financially impacted by the COVID pandemic.

Who is eligible? Applicants who meet all of the following criteria may qualify for KERA assistance:

- Tenant rents their home.
- -Tenant's 2020 household income did not exceed 80 percent of their area's median income.
- -At least one member of the tenant household is experiencing documented financial hardship as a result of the COVID pandemic. Hardship may include loss of employment, reduction in household income, or significant COVID-related expenses (medical bills, personal protective equipment, child care costs, equipment or internet costs to enable online work/schooling, etc.).
- At least one member of the tenant household is uncertain where they will stay or may become homeless without housing assistance.
- Tenant can provide valid proof of identification.
- Tenant resides in Kansas but outside Wichita. Wichita residents may apply for assistance through the Wichita Emergency Rental Assistance Program (WERAP), administered by the City of Wichita.

What does assistance cover?

- -Up to 12 months of residential rent and rental arrears.
- -Up to three months of prospective rent at a time, even if the household does not have rental arrears.
- -Past due residential utility and home energy (electric, gas, water, sewer, and trash service) and internet costs.
- Note: All expenses must have been billed or charged April 1, 2020 or later.

How to apply:

- -Both landlord and tenant must apply via a joint online application process.
 - Landlord completes online certification.

Tenant submits online application.

Landlord and tenant are notified when application is processed. If approved, landlord and/or service provider(s) receive funds

directly from KHRC. Landlord and/or service provider(s) apply assistance to tenant account.
