REGULAR COUNCIL MEETING CITY OF UDALL

Monday, October 12, 2020

The Udall City Council met for the Regular Council Meeting on Monday, October 12, 2020, at 6:30 p.m., at the Udall Community Building. Stephen R. Brown, Mayor, called the meeting to order. Council members present were Janette Adams, Kenneth Ault, Brandon Lawrence, Matt McAllister, and Carlton Smail. Quorum established. Also present were Teresa Russell, Tony Russell, Erik King, Eric Allen and Lulita Hopkins.

MODIFICATION OF THE AGENDA:

<u>BUSINESS FROM THE FLOOR:</u> Teresa Russell inquired about a possible real estate purchase by the City of Udall. It was not confirmed and only an offer than had been made. She exited the meeting.

GENERAL DISCUSSION:

1. K-15 Demo Derby on October 24 – K-15 Demo Derby requested use of the arena, one maintenance employee, sound system, police coverage and waiver of the rent fee.

MOTION: by Adams, second by McAllister, to approve the arena use waiving rent, one maintenance employee, sound system and police coverage for their event on October 24. All voted aye, motion carried.

2. Halloween will be as traditionally observed on Saturday, October 31.

CONSENT AGENDA:

MOTION: by Adams, second by McAllister, to approve the consent agenda including the Regular Meeting minutes of September 14, 2020, Treasurer's and Clerk's reports for September, Expenditure Report in the amount of \$210,225.36 and Payroll Account Report of \$26,263.81. All voted aye, motion carried.

OLD BUSINESS:

- 1. Library/Wellness Center
 - a. Pre-Bid meeting with Contractors is scheduled for November 5 at 2:00 pm
 - b. Bid Opening will be on Wednesday November 18th at 2:00 pm
 - c. USDA Letter of Condition is anticipated at the November council meeting
- 2. Renew Lease Agreement with Old Skool Productions; expiring October 18, 2020. Tony Russell was present to sign the lease which extended their use of the property until October 18, 2020.

MOTION: by McAllister, second by Smail, to approve the lease extension as prepared and signed. All voted aye, motion carried.

NEW BUSINESS:

1. Changes to Level Pay customer's program – With the new software, there are changes to the level pay system. One change is having customers sign once, instead of annually, to participate in the program. They will be informed of the new average payment amount with their January billing. It will be the customer's decision to inform us if they wish to discontinue the program.

MOTION: by Ault, second by Adams, to approve the proposed changes to the Level Pay program. All voted aye, motion carried.

2. UPC recommendation Zoning Variance BZA-V-2020-004. This application made by the Dollar General property owners requested a variance on the zoning setback for their facility. The State of Kansas Department of Transportation made changes to their entrance requirements that will push the building back farther. The application was reviewed by the Udall Planning Commission and their recommendation was to approve.

MOTION: by Ault, second by Smail, to approve the BZA-V-2020-004 presented by the Udall Planning Commission. All voted aye, motion carried.

3. Kansas Power Pool – Designation of Voting Delegate and Alternates. Eric Allen was selected as Voting Delegate and Matt McAllister as Alternate.

MOTION: by Lawrence, second by Ault, to approve KPP Voting Delegate and alternate. All voted aye, motion carried.

4. Advantage Computer – Contract renewal and support in the amount of \$2,271.00

MOTION: by Ault, second by Adams, to approve the Advantage Computer contract renewal and support \$2,271.00. All voted aye, motion carried.

5. Bids on line replacement, 2nd and Williams. Bids have been received from Kilian and J.F. Electric, but an underground bid is still outstanding. Item to be tabled.

MOTION: by by Ault, second by Lawrence, to table item to November meeting. All voted aye, motion carried.

6. CMB License for K-15 Motorsports – Demo Derby event on October 24, 2020.

MOTION: by Lawrence, second by Ault, to approve Cereal Malt Beverage application contingent upon receipt of insurance, \$75 fee, and background check. All voted aye, motion carried.

PUMPKIN CRÈME BRULEE

sugar

Cooking Spray
½ cup sugar
1 ½ cups unsweetened
canned pumpkin
1 ½ cups 2% milk
½ tsp pumpkin pie spice
½ tsp maple extract
½ tsp vanilla extract
1/8 tsp salt
4 large eggs, lightly beaten
¼ cup firmly packed brown

From Udall T.O.P.S. (Taking Off Pounds Sensibly) 6:30 pm each Thurs Methodist Church 305 S Church

Preheat oven to 350°. Coat 8 ramekins with cooking spray; place on a baking sheet.
Combine sugar and next 7 ingredients; stir well with a whisk. Divide evenly among ramekins.
Bake at 350° for 35 minutes or until almost set.
Remove from baking sheet; let cool 30 minutes on wire rack. Cover and chill at least 4 hours.
Uncover; press brown sugar through a wire sieve onto each custard. Place ramekins on baking sheet; broil 3-4 minutes or until sugar melts. Serve immediately. YIELD 8 servings.
