



#### UDALL CITY COUNCIL MEETING MINUTES June 14, 2023

The Udall City Council met for the City Council Meeting on Wednesday June 14th, 2023, at 6:30pm at the Udall City Building Council Room. Matt McAllister, Mayor, called the meeting to order. Council members present were Randy Hoffman, Damon Wilson, Dan Rutschman, and Mitch Kratochvil. Ouorum established. Also present were Jennifer Harness, Monica Rupp, Ernie Daniels, Marilyn Pelligrini and Jennifer Mays. Modification to Agenda – Correction to address for Old Business item 2 (166 and 118 First Street) and Make the Executive Session New Business #9.
